

EXTRACT OF THE INTERN REGULATIONS

The dates of the sojourn indicated in the reservation are meant as follows: the first the one of the arrival, the second the one of the departure. The check-in for the bungalow is scheduled in the hours between 14:00 and 20:00.

The check has to be payed within the day after the arrival.

The camping space has to be liberated within 12:00 on the departure day.

IT IS FORBIDDEN

- a) To leave waste outside the foreseen containers;
- b) To disturb the neighbor's rest with any noise in between the hours from 24:00 to 08:00 and from 14:00 to 16:00;
- c) To switch camping places without the further authorization of the direction;
- d) To accommodate other persons on the camping place;

Visits of family or friends have to be previously authorized by the direction. The access of strangers is strictly forbidden. Non-authorized persons caught at the inside of the structure will be removed or announced to the police for trespassing as in art. 614 P.C. Money, credit cards and other valuable articles can be deposited in the safe at the main office. The direction will not take any responsibility for objects stolen outside of this safe. Cars have no access to the structure during the hours in between 24:00 and 08:00 and 14:00 and 16:00. Clients who wish to enter or exit the structure during this time, can park their vehicles outside the entrance and use the pedestrian crossing that will remain open.

The entertainments organized by the direction can exceptionally last longer than the indicated resting hours.

The clients are gently requested to leave their bungalow clean (dishes washed) and tidy when leaving.

Owners of sailing boats, motor boats or windsurfs have to use the delimited canal for the exit to the sea and for the return and use the designated parking areas.

Dogs are admitted if small sized, always on the leash and respecting the hygienic norms of the direction. In case of non-respect of these norms, the direction reserves itself the right to remove the dog's owners.

The cars have to be parked on the designated parking lots, which cannot be reserved leaving objects on it.

REGULATIONS FOR THE STAY OF ANIMALS IN THE STRUCTURE

In order to ensure a pleasant stay to all of our clients on holiday with their pets, here are some rules that you are kindly requested to respect:

- All animals staying in the structure have to be microchipped, in possession of a health service card and a badge with the owner's phone number.
- Females in heat can provoke excitement, aggressiveness and perturbation in male dogs. It is not recommended to bring females in heat to the beach or places with the presence of other animals.
- All animals have to be kept on the leash in all public places of the structure.
- The animals can never be left unattended in the room or the apartment. If it is impossible for the owners to bring them along, please inform yourself about dog sitting services or other alternative solutions at the reception.
- In case of presence of cleaning staff in your room, please keep your animal on the leash. In case the staff finds an animal alone in the room, the room won't be made up and the staff is obliged to inform the owners about the rule infraction.
- Pet owners assume the whole responsibility in case of damages (personal or material) made by their animals in and outside the structure and they respond for the repair or substitution of all objects damaged or soiled.
- During the resting hours (14:00-16:00; 24:00-08:00), we ask you to pay maximal attention to your pet in order not to disturb other clients.
- The solid dejections have to be picked up and the liquid ones have to be sprinkled with water, in and outside the structure.
- Pets are not allowed in the following areas: children playground, restrooms of the camping, etc.
- Stray animals cannot be brought to the structure or even brought home, they have to be signaled to the police (0884708014) or the local animal foundation ANPANA: ass.anpana.vieste@gmail.com or 3205347038.
